



2018 PGA JR. LEAGUE SCHOLARSHIP PROGRAM

OVERVIEW

- ▶ The DICK'S Sporting Goods Sports Matter program is making a \$500,000 donation over the next three years to PGA Jr. League, matched by PGA REACH, for children who qualify for financial assistance or are from a military family.
- ▶ All dollars will go towards funding eligible youth players captained by PGA or LPGA Professionals. The start date for scholarships being offered is February 1, 2018.
- ▶ Recognition for the Sports Matter donation will only be associated with the leagues and teams they are directly helping to fund.

FACILITY ELIGIBILITY

- ▶ Any facility with a PGA Jr. League program captained by a PGA or LPGA Professional is eligible to receive scholarships.

PLAYER ELIGIBILITY

- ▶ Scholarships are available to youth players who qualify for financial need or for those who come from a military family. There is no maximum on the number of players from a program or team that can qualify for scholarships.

▶ FINANCIAL ASSISTANCE SCHOLARSHIP

Financial need is defined by players who meet one of two criteria in the following financial means test:

- Free or reduced lunch at school
- Extenuating circumstances (loss of employment, medical bills, other)

From the parents' point-of-view, this is a full scholarship that covers the player's total program fee, including the \$75 PGA REACH league fee. For example, if the total program fee is \$250, the parent will receive an online coupon for \$250.

From the Captain's point-of-view, if he/she derives personal income from PGA Jr. League registration fees and/or the majority of his/her income is from instruction, then he/she qualifies to receive a coaching fee from PGA REACH in the amount of \$100 per scholarship player. **Please note that it is not permissible to collect a separate registration fee from the scholarship recipient.**

▶ MILITARY SCHOLARSHIP

Participants qualify for the military scholarship if they are a child of Active Duty, Retired, or Reserve members of the military.

The military scholarship covers the \$75 PGA REACH league fee. It is permissible for Captains to collect the balance of the program fee if chosen to do so. For example, if the total program fee is \$250, the parent will receive an online coupon code for a discount of \$75 and will pay \$175 to join the team.
