ESSENTIAL DUTIES:

Under the direct supervision of the General Manager, the Head Golf Course Superintendent is responsible for maintaining turf golf courses. The Head Golf Course Superintendent will supervise and train the maintenance staff to provide golf course/playing conditions commensurate with the expectations of guests at a high-end destination resort and within established budgetary guidelines; oversee staff selection, employee reviews, training and scheduling processes; supervise all course operations, including irrigation operations, seasonal agronomic practices, and application of all pesticides, fertilizers and soil conditioners; possess interpersonal skills needed to effectively lead and motivate the maintenance team daily. Able to communicate effectively with the Pro Shop staff as it relates to daily operations, special events and maintenance schedule. Able to maintain and process timesheets for maintenance staff. Must be proficient in computer irrigation software operations.
